DSCC Campus Police & Security Officers:

DSCC Campus Police & Security officers have the authority to ask persons for identification and to determine whether individuals have lawful business at DSCC campus locations. Campus Police & Security officers have the authority to issue parking

tickets, which are billed to financial accounts of students, faculty, and staff. Campus Police Officers are commissioned Officers who are Tennessee Peace Officer Standards & Training (POST) certified. Campus Police Officers do carry weapons and have the authority, under applicable Tennessee laws, to arrest or detain any person on a DSCC campus or at a Center. However, Campus Security Officers are non-commissioned, do not carry weapons and do not have any authority, under applicable Tennessee laws, to arrest or detain any person on a DSCC campus or at a Center.

Criminal incidents are reported to Campus Police & Security who will refer the incident to the local police who have jurisdiction over that campus location. The Campus Chief of Police, Campus Police & Security Officers, and campus administrators maintain a highly professional working relationship with local law enforcement agencies at each location. DSCC strongly encourages its Campus Security Authorities (CSA) to inform all crime victims and witnesses of the procedures to report crimes on a voluntary, confidential basis to Campus Police & Security, as well as local pastoral and professional counselors. Prompt reporting will assure timely warning notices on campus and timely disclosure of crime statistics included in the annual disclosure of crime statistics.
