03:06:00:00 DSCC Prior Learning Assessment Policy

Purpose:

The purpose of this policy is to define Prior Learning Assessment (PLA) and place a maximum of 30 semester hours credit allowable to be earned through Prior Learning Assessment (PLA) towards the completion of degree requirements. Exceptions to the 30-hour maximum may be made in cases of veterans receiving education benefits.

Scope:

This policy applies to the entire college student body.

Policy:

In an effort to increase graduation rates and promote the "Drive to 55," the following are additional means of earning credit through Prior Learning Assessment.

- Advanced Placement
- Armed Services Credit
- Cambridge International Examinations
- College Level Examination Program
- Credit for Certified Administrative Professional (CAP) Rating
- Credit for Emergency Medical Technician Courses
- Credit for Advanced Emergency Medical Technician Courses
- Credit for English Composition Based on ACT Scores
- Credit by Department Examination
- Credit for Tennessee Law Enforcement/Corrections Academy
- Credit for Tennessee Colleges of Applied Technology
- International Baccalaureate Examinations

A maximum of 30 semester hours credit will be allowed towards degree requirements. The 30 hours awarded are not included in the total of hours required to fulfill the 25% residency requirement.

Compliance:

In order to be awarded credit, official documentation must be presented to the Office of Admissions and Records. Credit will be assessed and awarded according to the criteria in each area as outlined below.

- Advanced Placement
- Official scores of 3, 4, or 5 on the Advanced Placement Test must be submitted to the Office of Admissions and Records. AP credit that is listed on an official academic transcript from another regionally accredited institution will be honored.
- Armed Services Credit
- Army DD214 & AARTS transcript or DD295 or JST transcript
- Air Force DD214 & Community College of the Air Force Transcript or DD295
- Army National Guard DD214 & AARTS transcript

- Marines DD214 & DD295 or DD2586 or Joint Service Training (JST) transcript
- Navy DD214 & DD295 or DD2586 or the Sailor/Marine Corps American Council on
- Education Registry Transcript (SMART) or Joint Service Training JST transcript Cambridge International Examinations

- College Level Examination Program
- Credit will be given for acceptable scores in Subject Examinations only.
- Credit will not be given for scores in CLEP General Examinations
- The English Composition CLEP examination must include a written essay for credit to be awarded
- To receive credit for a CLEP examination, a student must attain a score of at least 50 as recommended by the American Council on Education (ACE). Official test scores from Educational Testing Service or CLEP credit posted on an official academic transcript from another regionally accredited institution must be submitted to the Office of Admissions and Records before credit can be awarded. CLEP examinations may be taken on the Dyersburg campus by appointment.
- Credit for Certified Administrative Professional (CAP) Rating
- Sixteen (16) hours of college credit for successful completion of the CAP Examination will be awarded to students enrolled at DSCC. The student can choose 16 semester hours of credit from the following list:
- AOM 205 Records and Information Management 3 semester hours Or AOM 239 – Administrative Office Management – 3 semester hours
- AOM 221 Business and Office Communication 3 semester hours
- ACCT 1010 Principles of Accounting I 3 semester hours
- BUSN 2330 Principles of Management 3 semester hours
- BUSN 2370 Legal Environment of Business 3 semester hours
- ECON 2010 Macroeconomics 3 semester hours
- Credit for English Composition Based on ACT Scores
- DSCC awards six hours of credit for ENGL 1010 and ENGL 1020 to students with an ACT English sub score of 32 or above. Students who have previously taken ENGL 1010 and/or ENGL 1020 and earned a passing or failing grade are not eligible. Credit awarded by other regionally accredited institutions on the basis of ACT scores for ENGL 1010 and/or ENGL 1020 will be honored.
- Credit by Department Examination
- Students who have achieved competence equivalent to that offered in course of instruction at DSCC through on-the-job training, previous instruction, or other methods may receive credit by challenge examination. Student must complete 12 credit hours prior to having Credit by Examination credit hours placed on their transcript. Department examinations may not be taken in the elementary level of a field in which the student has received credit for advanced work. A student may challenge a course only one time, and a challenge may not be used to remove any grade previously recorded. The students will receive a grade of "Pass" or "Fail".

• Credit for Emergency Medical Technician (EMT) Courses – to be applied towards AEMT/Paramedic Certificate and respective AAS Degree.

Any applicant requesting PLA credit for EMT level courses must fully meet the following requirements:

- A. provide documentation of a high school diploma or GED.
- B. provide copies of relevant academic transcripts: high school, college or university, military service schools, and other (proprietary school; consortium programs; private EMS education companies).
- C. possess a VALID, CURRENT, and ACTIVE Tennessee Department of Health Emergency Medical Technician Basic License.
- D. submit a valid certificate of completion or letter from the educational institution where the student completed his/her EMT course.
- E. submit a resume' or curriculum vitae outlining work history with an emphasis on EMS or other health care experience.
- F. submit a VALID and CURRENT American Heart Association BLS Provider CPR certification card (No other CPR instruction entity certification cards accepted; only American Heart Association).
- G. applicants whose course completion is greater than 3 years old and whose Emergency Medical Services (EMS) work experience is less than 1 year from the date of application must complete a departmental exam with a score of 80% or above prior to the registration deadline.

Should an applicant successfully fulfill the above requirements, PLA credit shall be awarded for credit for EMSB 1601, EMSB 1602, EMSB 1101, EMSB 1102, EMSB 1111, and EMSB 1112.

- H. Student must complete 12 credit hours prior to having Credit by Examination credit hours placed on their transcript. Students can only take the test two times.
- Credit for Advanced Emergency Medical Technician (AEMT) Courses to be applied towards Paramedic Certificate and AAS Degree.

Any applicant requesting PLA credit for AEMT level courses must fully meet the following requirements:

- A. provide documentation of a high school diploma or GED.
- B. provide copies of relevant academic transcripts: high school, college or university, military service schools, and other (proprietary school; consortium programs; private EMS education companies).
- C. possess a VALID, CURRENT, and ACTIVE Tennessee Department of Health Advanced Emergency Medical Technician License.
- D. submit a valid certificate of completion from the educational institution where the student completed his/her AEMT course.
- E. submit a resume' or curriculum vitae outlining work history with an emphasis on EMS or other health care experience.
- F. submit a VALID and CURRENT American Heart Association BLS Provider CPR certification card (No other CPR instruction entity certification cards accepted; only American Heart Association).
- G. applicants whose course completion is greater than 3 years old and whose Emergency Medical Services (EMS) work experience is less than 1 year from the date of application

must complete a departmental exam with a score of 80% or above prior to the registration deadline.

Should an applicant successfully fulfill the above requirements, PLA credit shall be awarded for EMSA 1501, EMSA 1502, EMSA 1201, EMSA 1202, EMSA 1111, and EMSA 1112.

H. Student must complete 12 credit hours prior to having Credit by Examination credit hours placed on their transcript. Students can only take the test two times.

*Valid educational institutions that qualify for PLA are those that have been approved by the State of TN EMS office, TBR, CoAEMSP, or CAAHEP.

Credit for Tennessee Law Enforcement/Corrections Academy

- Students completing the prescribed training in 1991 or thereafter at the Tennessee Correction Academy may receive the following credit: CRMJ 1010 Introduction to Criminal Justice, and three semester credit hours of JST electives. Students completing the prescribed training in 1989 or thereafter at the Tennessee Law Enforcement Training Academy may receive the following credit: CRMJ 1010 Introduction to Criminal Justice and six semester credit hours of JST electives. This credit may be awarded once the student has completed a minimum of 12 college-level semester credit hours of at DSCC.
- Credit for Tennessee College of Applied Technology
- Students who complete certain courses, certificates and/or diplomas at the Tennessee Colleges of Applied Technology may be eligible to receive credit in specific DSCC courses. Statewide articulated courses offered at DSCC are listed in the table below. For more information, contact the President of the applicable College of Applied Technology; the DSCC Office of Admissions and Records; or the Dean of Business, Technology and Allied Health.
